

This will help reduce miscommunication between deaf and hard of hearing communities and the law enforcement.

WVAD Board Meeting Held at Days Hotel, Flatwoods/Sutton, WV, September 17, 2016

West Virginia Association of the Deaf's Mission Statement:

The regular board meeting of WVAD was held at Days Hotel in Flatwoods/Sutton, WV. President John Burdette called the meeting to order at 10:30 a.m. with Secretary Donna Williams present.

The minutes of the meeting held May 4, 2016, was sent via e-mail. It was corrected and approved via videophone and e-mail. The minutes of the meeting was published in the Summer 2016 newsletter.

Treasurer Veronda Harrison's Financial Report from May 13, 2016 to September 15, 2016:

President John Burdette's Report:

- financial support request for Bobbi Ann Hundley's trip to Jr. NAD Youth Leadership Camp.
- Received e-mail from WV Hands & Voices about planning for Deaf Awareness Week activities. WVAD will have an exhibit at their picnic September 24th.
- Communicated with WVCDHH about application for vendor at the State Fair of WV.
- Attended the NAD Region 1 monthly videophone meetings May 25 (focused on the NAD conference) and June 15 (not good meeting because of videophone problems). The next videophone meeting will be September 21.
- Received e-mail from NAD Region 1 representative, Michelle Cline, with attachment on the State Association and Affiliates Committee (SAAC) Took Kit.
- Received e-mail from WV Hands & Voices to share information about partnering with the National Early Childhood Assessment Project (NECAP).
- Attended WVSDB information meeting with Dr. Keller at Raleigh County Special Education Office in Beckley, WV. I gave a presentation about my experiences at WVSDB and about WVAD.
- Met with Bobbi Hundley at WVSDB to present her the scholarship award to attend the Jr. NAD Youth Leadership Camp in Oregon.
- Attended WVSDB graduation and presented scholarships to the Valedictorian and Salutation. Also

- presented free 2-year membership to 11 graduates.
- Received an e-mail from Tami Deem saying the Kroger Reward Program requires everyone to select their favorite organization on their rewards card yearly every September. This information will be in the newsletter.
- Letter to AG Bell was sent to the former president, current president, and the *Washington Post*. This letter was posted on Facebook and the WVAD website.
- Received e-mail from Earnest Covington asking for name signs of the towns and cities in WV. Ruby created a video showing the signs of the towns and cities in WV and sent to WVCDHH.

- The WVAD biennial picnic was held Saturday, August 13th, at Burnsville Lake. Sixty-one (61) people attended.
- Received e-mail from NAD Region 1 representative, Steve Lovi, asking about WV Emergency Assistance on behalf of NAD Headquarters to see if any WV deaf residents were having any storm/flooding related problems that needed to be brought to NAD's attention via FEMA. I replied the same day with the information.

at NAD, to review WV Floods Public Relations draft before being released. I replied the same day to update our website address.

- Received a SignMail from an attorney about a hospital in Huntington who had received a letter regarding mental health interpreting for their patients. Referred this to Secretary Donna Williams.
- Received an e-mail from Earnest Covington regarding the deaf person in NC who was killed by police shooting and asking about Communication Access Visor card. I replied explaining that WVAD had made the Communication Access Visor card several years ago to distribute to the deaf and hard of hearing communities.
- Called the WVCDHH to discuss the Communication Access Visor card. Rachel Rajca drafted a letter about the Communication Access Visor card and sent to me for review. After review, this letter was sent out via e-mail to several groups with invitation to participate in a meeting on Wednesday, September 14th. Larry Hubbard along with Ron Williams attended this meeting. I also participated via FaceTime (video conferencing). Tami Deem and I are working on the draft changes to the Communication Access Visor card by adding more visual aids.
- There will be Disability Awareness exhibits at Tamarack in Beckley on Thursday, October 20, and West Virginia State University in Charleston on Tuesday, October 25. Do we want to participate?

<u>Vice-President Tami Deem's Report:</u> None.

Secretary Donna Williams' Report:





Opportunity and Excitement at WVSDB

ROMNEY — When students arrive back at the West Virginia Schools for the Deaf and the Blind next Sunday to start the new school year, they will do so among many big changes and big ideas for both the present and the future. Staff got back to work on Monday, with a weeklong teacher in-service training.

"Our theme is literacy across the curriculum," said WVSDB Superintendent Martin Keller. "I feel that it's very important to continue to emphasize that in all classes. It's important for future success."

Focusing on literacy is just one of the core ideas being pushed in the classrooms at WVSDB, and with larger changes hopefully on the horizon, both the big and small adjustments are going to add up to a successful year.

Changes this year include a National Honor Society for both schools, with the 1st-ever induction ceremony being planned for November.

October 1st will be Homecoming, which will include a soccer tournament, as well as a dedication ceremony. The building housing the School for the Deaf has never been named. Consolidation of the elementary and secondary schools for the deaf occurred during the summer months to mirror the school set-up at the School for the Blind. The building will be named the Sevingy Academic Building in memory of long time teacher, coach, and mentor Pierre Sevigny.

Also during the month of October, WVSDB will host a regional robotics competition. FIRST LEGO League includes both a junior team at the elementary level and the one at the middleschool level. The program — for blind students — also includes what Keller calls an "exciting high-level design" competition team known as VEX.

Staff changes Keller highlighted were the addition of Michael Coleman — most recently the Special Education Director of Hampshire County Schools — returning to be principal, WVAD Quarter News, Fall 2016

and Kurt Metz as the new school neuropsychologist.

"We are very excited to have Mike on the team, and Kurt is a tremendous addition," Keller said. "Dr. Metz will work closely with both deaf and blind students and is also serving as director of the Center for Excellence in Teaching and Learning," which is a new diagnostic center in the former elementary building.

"We are ready to set that up and we will be up and running in about 2 weeks," Keller said.

In addition to boosting the strength of the curriculum and focused staff development, recruitment of new students remains a focal point. While the school lost 14 Seniors to graduation last year, they have added 10 new students, keeping the enrollment right around 130 students.

"I'm doing a big push to bring new students in," Keller said. That includes a trip to the West Virginia State Fair to meet prospective parents and children. Sometimes, Keller said, it can be a tough sell, but thanks to technology it is a bit easier than it used to be.

"Some parents want to keep their children home," he said. "It can be 3 or 4

hours away for some families. I try and explain that with today's technology the distance can be easier.

"We can use videophones and parents can communicate and see their children every day. Facetime and regular phone calls are also possible. Technology is able to lessen the pain for parents by providing them the opportunity of being able to see and communicate with their children every day."

Balancing the responsibility of working with parents and students on an individual and classroom basis is a stark contrast to trying to improve the facility on a grand scale, but those duties go hand in hand for Keller as he continues to improve the experience at WVSDB. Along with his Executive Assistant, Dr. Ann Getty, Keller has made a push to get the campus prepared for the larger changes that may come when and if the \$15 million funding the school has requested is approved by the State Legislature.


"The State Board told me to keep pressing on," Keller said. "This fall I want to designate a day for the school to host the Legislature to orient them to (See In the News on page 20)



the school and its services. I want them to meet the students and have them stay locally," he said.

Some other longer-term goals that will get off the ground this fall include:

- Working with Michelle Burnett and Eileen Johnson in the county Economic Development Office to evaluate the possibility of establishing a childcare center in the former elementary school building.
 - "The vision is to provide a program that would offer a degree in early childhood education," Keller said. "The students taking classes would then have exposure to the children from the get-go. It would essentially be a childcare training hub. Those children would be exposed to sign language as well, which would be a huge advantage for them." The center would also serve as a onestop place for diagnostic testing for both blind and deaf children, working closely with the State Department of Education.
- The school has been connected to a green specialist that will evaluate how to improve energy use at the school. An environmental consultant is also going to be doing a study as one of the preliminary measures of the hopeful extensive renovations that could be in store for the school. Hazardous materials in the buildings and possible underground issues will be identified; both services are being completed at no cost to the school. "It's huge," Keller said. "We were told if we were going to hire someone it would cost over \$100,000. It's pretty exciting."
- On September 30, the school will submit a proposal for Innovative Readiness Training through the United States Military. A list was made of the needs of the school building by building, which will be submitted to the Pentagon for review and the possibility of assignment.

"When the troops are deployed, they are doing so much more than fighting wars," Keller said. "They focus on school-building and repairs such as HVAC, plumbing, and electrical work. They need practice. We submit a wish list which will go out to units all over

the country, and a unit can choose their projects based on their needs." Military units would be able to live on campus while completing the necessary work. "That's an advantage we have," Keller said. "We can provide housing." "It's not a sure bet, but it's an opportunity."

The project would provide free labor and equipment, with only the building materials being funded by the school. Kelly Surveying Company is bringing a drone to do an aerial map of the campus. With that 3D model, all of that documentation will be completed prior to the submission of the proposal.

"All of those things will hopefully have a positive influence on the IRT process," Keller said.

All of the emotions, challenges, and triumphs of the new year will begin next week, and Keller — along with his entire staff — are looking forward to getting the 2016-17 year started on the right foot.

"We are very excited," Keller said.
"It's going to be good to be back."

1/4 cup balsamic vinegar 2 to 3 Tablespoons olive oil, divided 1 teaspoon dried thyme 1/2 teaspoon red chili flakes 1/4 teaspoon black pepper 1-1/2 pounds baby red potatoes, quartered 1 pound green beans, trimmed

6 Tablespoons honey 2 cloves garlic, minced 3/4 teaspoon dried rosemary 3/4 teaspoon kosher salt 2 pounds chicken breasts (4 each), trimmed 1 pint cherry tomatoes



- 1. Preheat the oven to 425 °F (175 °C).
- In a medium bowl, combine the balsamic vinegar, honey, a tablespoon of olive oil, garlic, thyme, rosemary, chili flakes, salt, and pepper. Stir well to mix.
- Place the chicken breasts in a resealable plastic bag and pour the marinade over the top. Seal and toss the chicken to evenly coat. Marinate for at least 30 minutes.
- While the chicken marinates, place the potatoes and cherry tomatoes on a sheet pan. Drizzle with the remaining olive oil, season with salt and pepper, and stir to coat. Bake for 25 minutes.
- Remove the sheet pan from the oven and toss the green beans with the potatoes and tomatoes.
- Remove the marinated chicken breasts from the plastic bag, reserving the remaining marinade in the bag. Place the marinated chicken, evenly spaced, on top of the vegetables. Pour the marinade from the bag over the top of the chicken and vegetables.
- Return the sheet pan to the oven. Bake for 30 to 40 minutes, periodically basting the chicken breasts with the pan juices, until the internal temperature of the chicken reaches 165 °F (74 °C).
- Allow the chicken to rest for 5 to 10 minutes. Spoon the pan juices over the top of each chicken breast before serving.



PUMPKIN MAGIC CAKE

For the Cake:

1 box of yellow cake mix plus ingredients needed to make the cake (eggs, water, oil)

For the Pumpkin Pie:

1 15-ounce can pumpkin puree 1/2 cup heavy cream 1 cup brown sugar

3 eggs 1 teaspoon pumpkin pie spice

1/2 cup evaporated milk

For the Frosting:

1 box (4 serving size) vanilla instant pudding mix 8 oz Cool Whip, thawed

1 teaspoon pumpkin pie spice

1 cup cold milk



- Preheat oven to 350 °F.
- Prepare box of cake mix according to package instructions, then pour into a lightly greased 9"x13" cake pan. DO NOT BAKE. Set aside.
- In another bowl whisk together the ingredients for the pumpkin pie (pumpkin, evaporated milk, cream, eggs, brown sugar, and pumpkin pie spice) until smooth. Slowly pour the pumpkin pie mixture on top of the unbaked cake mix.
- Carefully place cake into the oven and bake for 50-60 minutes or until the center is no longer jiggly and a toothpick inserted into cake mix comes out clean. NOTE: The cake might be slightly darker than normal, but it still taste great. Let cool to room temperature.
- To make the frosting, place the vanilla pudding mix into a large bowl, add the pumpkin pie spice, and pour in the cold milk. Whisk until combined and it starts to thicken. Gently fold in the Cool Whip until it's completely mixed. Spread on top of the cooled cake.
- 6. You can serve now, or chill the cake and serve when chilled. Either way tastes great. Enjoy!

NOTES:

Before baking the cake, you can place it on top of a rimmed baking sheet just in case any of the cake spills over the edge of the pan while baking. After you are done baking the cake, it may look like it did not settle into layers, but it has! After frosting the cake, top with butterscotch or chocolate chips if desired or sprinkle with pumpkin spice if desired.
