### WVAD Officers Travel to U.S. Capitol in Washington, D.C., March 2, 2016 By John Burdette

John Burdette and Donna M. Williams attended the Alice Cogswell and Anne Sullivan Macy Act, H.R. 3535 Advocacy Day in Washington, D.C. on March 2, 2016. They represented West Virginia Association of the Deaf (WVAD), along with 10 other individuals from the WV Schools for the Deaf and the Blind (WVSDB) and WV Commission for the Deaf and Hard of Hearing (WVCDHH) plus three (3) students from WVSDB. We left at 5:00 a.m. and rode the bus to Washington, D.C. to get there in time for the kick-off rally at 8:30 a.m. It was a historic day for many of us who attended the Advocacy Day.

Alice Cogswell and Anne Sullivan Macy Act, H.R. 3535 Advocacy Day was organized by the Conference of Educational Administrators of Schools & Programs for the Deaf (CEASD) and Council of Schools and Services for the Blind (COSB).

H.R. 3535 was introduced into the U.S. House of Representatives in September 2015 by Representatives Matt Cartwright (D-PA) and David McKinley (R-WV). The bill is named for Anne Sullivan, Helen





Keller's beloved teacher, and Alice Cogswell, the first deaf girl to be educated in a school for the deaf in the United States. The original bill (H.R. 4040) was introduced in the previous Congress. This updated version of the Alice Cogswell and Anne Sullivan Macy Act includes additional language to support students who are

deaf-blind. Advocates for students who are blind/visually impaired, deaf/hard of hearing, and deaf-blind have worked tirelessly with legislators to compose three strong, parallel titles within the Act, addressing the needs of students in these three sensory-disability areas.

The House Bill 4485, Deaf Children's Bill of Rights Act (DCBR), for West Virginia was introduced in the House on February 10, 2016.
 Last action was to House Education Committee. We were warned by Ruth Rowan, House of Delegate, about this bill, that it will not

be passed in Legislative this year. 2016 Legislative session ended on March 12th. WVAD Education Committee will continue to work on this bill for the next couple months as well to get more sponsors from the legislators.

 First Annual Deaf Awareness Day was held at the WV State Capitol, Charleston, WV, on March 8, 2016. The event was hosted by the WV Commission for the Deaf and Hard of Hearing (WVCDHH) and WV Association of the Deaf (WVAD). It was very successful with approximately 100 people and 25 vendors.

On May 21, 2016, Saturday, a free workshop about SSDI and Employment will be offered by the WVCDHH at the Louis Bennett Public Library from 10:00 a.m. to 12:00 p.m. in Weston, WV, for the Deaf and Hard of Hearing community members.

On July 5-9, 2016, 53rd Biennial National Association of the Deaf Conference will be held in Phoenix, Arizona.

## WVAD Board Meeting Held at Marion County Public Library, Fairmont, WV, March 5, 2016

### **West Virginia Association of the Deaf's Mission Statement:**

The West Virginia Association of the Deaf, Inc., (WVAD) operated by, of, for the Deaf Community, advocates, and promotes to improve the quality of life for deaf and hard of hearing individuals including but not limited to deaf-blind individuals, parents of deaf children, interpreters, late-deafened adults, and children of deaf adults.

Members Present: John Burdette, Tami Deem, Veronda Harrison, Donna Williams, Larry Hubbard, Worthy Devericks, and Jeffery Simmons.

<u>Visitors Present</u>: Sally Hubbard and Lois Devericks.

The regular board meeting of WVAD was held at the Marion County Public Library in Fairmont, WV. President John Burdette called the meeting to order at 9:45 a.m. with Secretary Donna Williams present.

The minutes of the meeting held November 7, 2015 was sent via e-mail. It was corrected and approved via videophone and e-mail. The minutes of the meeting was published in the Winter 2016 newsletter.

### <u>Treasurer Veronda Harrison's</u> <u>Financial Report from November 6,</u> <u>2015 to March 4, 2016</u>:

Balance in checking account – \$2,150.27; balance in savings account – \$3,564.71; Mingo County Fund – \$14,543.66; WVAD Conference Fund – \$2,801.16; Deaf Youth Program – \$1,278.00; 2 Certificate of Deposits – \$12,003.63.

- Christmas Party: 81 people attended. Total assets \$2,994.00; total expenses \$2,289.63. Profit \$704.38.
- <u>Picnic</u>: Called Summersville, Coonskin, and Burnsville/Bulltown.
   Summersville shelter holds only 50 people; Coonskin shelter holds 100 people and cost \$200; Burnsville/Bulltown shelters hold 100 people and cost \$80.

Donna moved to accept the Treasurer's report after correction. Passed.

### **President John Burdette's Report:**

- Ramada Downtown Charleston: John called the Kanawha County Magistrate Court to check the status. They told him the letter was sent to Ramada Downtown Charleston via a police officer; however, this failed because the clerk said the letter was undeliverable, probably due to wrong name of hotel or address. Received a letter from the Kanawha County Magistrate Court with a form, Veronda had Sheriff's Department delivered. Called the Magistrate Court with questions. WVAD can send the civil complaint form again with an amended change, but we might have to pay the fees again for Sheriff's Department to deliver the letter to Ramada Downtown Charleston.
- Glade Springs Resort (GSR): John informed Greg Haynes, Sales Manager, via e-mail that WVAD has selected Glade Springs Resort for our next conference in 2017. John received an e-mail from Susan Kennison with the contract attached. A few things that were negotiated include: Breakfast buffet was reduced to \$10.00. One complimentary activity "Fun Pass" will be included with the room at no extra cost for several events. The "Fun Pass" per attendee includes scavenger hunt, geocaching card, one round of disc golf (includes scorecard and disc rental), one complimentary game

- of bowling, one hour boat rental at Lake Mallard, and one bucket of driving range balls. Can reserve same as hotel do not have to pre-pay until arrival. Group code: WVAD. If want to arrive one or two nights earlier or stay one or two nights longer (up to two nights), the price per night will be the same as for WVAD conference. John will visit Glade Springs Resort on Monday, March 7, 2016, to finalize and pay the required \$1,000 deposit.
- NAD Regional 1 monthly VP meeting: John attended the meeting on January 12 and February 17, 2016.
- An e-mail was sent to April Hottle, WV Education Advocate, and Antonia Vaughan, Legislative Advocate, asking them if they are interested in attending the Legislative Training workshop provided by Fair Shake. Neither can attend due to school commitments.
- The annual Fair Shake Disability Advocacy Day at the State Capitol was held Wednesday, February 10, 2016. John attended for Sprint Relay. Those attending for the WVAD exhibit were Larry Hubbard, Donna Williams, and Julie Simmons.
- Received e-mail December 18, 2016, about an announcement that WV counted nearly 600 teachers in WV who are not certified. WVAD Education Committee needs to inquire if any of these non-certified teachers (or interpreters) work with the deaf and hard of hearing students.

- National Deaf Youth Day— Contacted Allie Rice at NAD asking about Deaf Youth Day. NAD wanted to have the event on March 6, 2016, to follow Deaf President Now (DPN) date. However, March 6 is on Sunday this year. But, it can be any day.
- November 17, 2015, received e-mail from Toni about the Alice Cogswell-Anne Sullivan Macy Act (HR 3535) in the U.S. House. Currently they have two (2) co-sponsors—Representative Matt Cartwright from Pennsylvania and Representative David McKinley from WV. We need to send letters to them to push for this act to pass.
- Received e-mail from Lakeview Golf Resort & Spa asking if want to have conference there in the future. It is near Morgantown, WV.
- Received an e-mail from Molly Simonton at Marshall University inviting Donna and me to attend a WV Deaf/Hard of Hearing Educational Advisory Social on Tuesday, January 12, 2016, in Charleston, WV. Neither of us were able to attend.
- Received another e-mail from Molly inviting Donna and me to a become part of a Stakeholder's group focusing on education of deaf and hard of hearing children in WV. The first meeting will be Tuesday, March 22 1:00 to 3:00 p.m. at Pierpont Community & Technical College in Fairmont.
- Received an e-mail from Dr. Martin Keller, Superintendent of WVSDB inviting WVAD to visit WVSDB again spring 2016—maybe during Family Student Day May 13-15, 2016.
- Received an e-mail from United Deaf Service (UDS) explaining that they have a new person working there. The check will be sent soon.
- Received e-mail from Toni about a bill for license plate for deaf—third day after session started. Many comments were posted on Facebook plus several e-mails sent to co-sponsor Ruth Rowan. Learned that one person wants this license. However, the bill says the license "may" be purchased. It will not be required. This bill apparently failed because no action was taken.

- Received an e-mail from Steve Lovi, NAD Region 1 representative, asking if there were any problems communicating with the deaf and hard of hearing communities during Snowstorm Jonas. John shared that there were several communications on Facebook. It is one of NAD's 5 priorities to check on state Emergency Plans.
- Received an e-mail from Dr. Martin Keller, Superintendent at WVSDB, about the rally at the U.S. Capitol regarding the Cogswell-Macy Act. He invited WVSDB alumni, WVAD officers, WV Commission for the Deaf and Hard of Hearing (WVCDHH), WVSDB students, etc.
- Donna and I learned at the Fair Shake Disability Day on Wednesday, February 10, 2016, that the Deaf Children's Bill of Rights bill now has a number (HB 4485) and that it would be introduced to the House that afternoon. We spoke with Delegate Ruth Rowan who sponsored this bill that the WV budget is the worse since either 1983 or 1989. That is why the draft that WVAD **Education Committee submitted** was changed so much to delete anything that had any financial requirements. Delegate Rowan also warned us that this bill will probably not pass but we can try again next year. I asked her if the new bill will have the same number and she said probably not. Donna will explain more in her report.
- Learned that Senator Manchin's wife (Gayle Manchin) will be on the WVSDB Advisory Board.
- Received an e-mail from WVDBA asking if WVAD want to advertise in WVDBA program book for the 30th Anniversary Bowling Tournament.
- Received an e-mail from Toni regarding 12-step programs and funerals being required to hire interpreters under the Title III of the ADA law. These are considered public places.
- Received an e-mail from WVCDHH sharing information about a workshop on Saturday, May 21, 2016, at Weston Library 10:00 to 12:00 p.m. about SSDI and Employment. The presenter is Deaf and will sign the presentation in ASL. Must inform WVCDHH if planning to attend.

- E-mail was sent to WVAD board regarding exhibits at Bridge Valley Fair (full now but will let us know for October) and One4All Disability Expo April 2 in Huntington (\$40).
- Received an e-mail from Travis Shrodes, Firefighter/Paramedic, asking about sign language class in the Martinsburg area for first responders. I replied referring him to Blue Ridge Community and Technical College.
- Received e-mail from Steve Lovi, NAD Region 1 representative, asking for WVAD membership. Sent the information to him.
- WVAD and WVCDHH would like to provide an exhibit at the State Fair.
- Deaf Awareness Day Tuesday, March 8, 2016—10:00 a.m. to 3:00 p.m. at the State Capitol. There will be 22+ vendors. At 10:30 a.m. and 1:30 p.m. WVSDB Tapestry group will sing and sign. Can make appointment with legislators.

<u>Vice-President Tami Deem's Report:</u> None.

### Secretary Donna Williams' Report:

- Deaf Awareness Day: Handouts will be distributed at the WVAD booth
- WV Early Hearing Detection Intervention: NAD strongly encourages each state to try to get a member on the advisory board. Learned that one deaf person on the advisory board is a late-deafened person and is a member of WVAD. The advisory board meets 2 or 3 times a year in Charleston during the day. The next meeting will be on March 24, 2016. If interested in being on this advisory board, need to send an e-mail to Tennysa Mace with name, e-mail address, phone number, and organization affiliation. Member MUST live in WV.
- Workshop Surveys: Distributed the latest copy. Forgot to add "conference" so it was added during the Christmas party. Results from Christmas party were 6 responded.
- Alice Cogswell-Anne Sullivan Macy Act in the U.S. Congress: Dr. Martin Keller invited John and me as WVAD representatives as

Southwestern group include Gwen Bryant-WV Hands & Voices and parent, Ruby Losh-WVSD Alumni and parent, Christina Payne-WV Hands & Voices and parent, Ressie Thomas— WVSDB Outreach Specialist, Julie (Barie) Turley-CODA and Deaf Education teacher, and Antonia Vaughan-WVAD Legislative Advocate and education interpreter. Northeastern group include Christie Ryan Graham—parent of pre-school deaf child at WVSD, Tammy Phillips—principal at WVSD and former Deaf Education teacher in mainstreamed program, and Dr. Martin Keller—superintendent at WVSDB. Any questions please ask John, April, or Donna. Southwestern group met November 29 and December 6, 2015. Both groups met in Fairmont January 9, 2016, and completed the final draft. I revised the draft and sent to all committee members for feedback. Communicated several times with Kim Bianco-Majeri, NAD Legislative Advocate, for advice. She was very helpful. January 18, 2016, the final draft of the WV DCBR the committee did was sent to Sponsor Delegate Ruth Rowan and Bill Writer John Reed. I communicated with them several times. They told me the draft DCBR required money for certified interpreters and teachers and WV is in budget deficit. They changed it to follow the DCBR in Louisiana almost exactly. Most of the Education Committee members were not happy about this and wanted to change it again. However, all members agreed to leave it as it is and amend later. February 10, 2016, the bill was introduced to the House of Representatives as HB 4885. It was sent to the WV Legislative Education Committee February 10, 2016; however, no action was taken; therefore, the bill 'died'. Membership Larry Hubbard's Report: At 2015 WVAD conference, there were 197 members. Now, there are 177 members.

### Education Advocate April Hottle's Report via E-mail:

- Over the past several months I have worked with Donna and the WVAD Education Committee members drafting the Deaf Children's Bill of Rights (DCBR). It has been a positive experience. We look forward to DCBR (HB 4485) becoming law.
- West Virginia Deaf Awareness Day at the State Capitol is March 8, 2016. The Capital High School American Sign Language Club and students who are deaf or hard of hearing will attend. Our schedule includes observing the Senate, watching the WVSDB group, touring the Cultural Center Museum, and observing the museum use their technology that provides an interpreter, visiting the various booths and demonstrations on the Rotunda and eating lunch at the Rolling Smoke restaurant. We will return to CHS at noon. The ASL students are looking forward to practice their sign language skills with native signers.
- The Annual Optimist Deaf & Hard of Hearing Speech Competition will be held in April. Capital High School staff are encouraging the students who are deaf or hard of hearing to participate. The Optimist Club offers \$2,500 as prize money to the winner.
- As the Education Advocate, I continue to promote excellence and high expectation for deaf and hard of hearing students by communicating with staff who work directly with teachers to implement IEP's and promoting regular education classroom work.
- I am proud to be affiliated with WVAD as you work hard to pass DCBR and continue to serve deaf and hard of hearing people in the state.

### <u>Legislative Advocate Antonia Hall's</u> <u>Report via E-mail</u>:

 Kept John and Donna informed about HB 2433 regarding license plate for the Deaf.

- Kept John and Donna informed about HB 4147 regarding making West Virginia Schools for the Deaf and the Blind eligible to participate in any and all funding administered or distributed by the WV School Building Authority. Sent to Finance Committee February 15, 2016. It 'died' in the Senate.
- Kept John and Donna informed about HB 4485 regarding the Deaf Children's Bill of Rights. It was referred to the WV House Education Committee on February 10, 2016; however, no action was taken.

Everyone met in Cannon House Office Building, Room 122, at 8:30 a.m. for the kick-off rally about this bill. They shared many points about why this bill is needed. The bill needs to gain more sponsors in the House, and it needs to be introduced in the Senate. Individuals with Disabilities Education Act (IDEA) is designed to meet the needs of all eligible students, but students who are deaf, hard of hearing, blind, visually impaired, or deaf-blind fall through the cracks. These children are considered "low incidence."


IDEA says schools must elevate these students, identify and meet their educational needs, provide qualified teachers and service providers, and place them in a setting that supports their learning. However, in most states and school districts, the schools do not have strategies and resources to make that happen. With H.R. 3535, this will strengthen IDEA to improve results for deaf, hard of hearing, blind, visually impaired, and deaf-blind children, including those with additional disabilities.

After the kick-off rally, we all went to the cafeteria in the basement for breakfast/lunch while waiting for our scheduled appointments with WV legislators in the afternoon. We made visits to Senator Joe Manchin, Senator Shelley Capito, and Representative David McKinley's offices to ask them to support this Act. We didn't get to meet with Senator Manchin, but we met with Senator Capito and Representative McKinley. Representative McKinley told us he had been deaf in his left ear for 40 years and now he wears cochlear

implant. He also has a 9-year-old grandson who is deaf living on the west coast. He knows some sign language but not having his grandson nearby to communicate with, he does not use it much.



### WV Deaf Children's Bill of Rights (DCBR)

The National Association of the Deaf (NAD) encouraged each state to draft a Deaf Children's Bill of Rights (DCBR) and push to have it passed. So far, there are 18 states that have DCBR. West Virginia Association of the Deaf (WVAD) agreed to start working on this. However, the board agreed to wait until NAD completed the model bill and sent it out. NAD announced at the National Leadership Training Conference (NLTC) last fall that it had been completed. We received the copy on October 12, 2015.

In the meantime, WVAD Education Advocate, April Hottle, and WVAD Legislative Advocate, Antonia Vaughan, were busy recruiting people that are willing to serve on the WVAD Education Committee to work on this bill. In addition to April, Antonia, and Donna Williams, WVAD Board ad hoc, nine (9) people were recruited. They are:

- Christie Ryan Graham Parent of pre-school deaf child at WVSD
- Tammy Phillips Principal at WVSD and former Deaf Education teacher in mainstreamed program
- Dr. Martin Keller Superintendent at WVSDB

On Friday, November 6, 2015, Donna met with some of the northeastern group and Delegate Ruth Rowan in Romney, WV. Delegate Rowan is on the West Virginia Schools for the Deaf and the Blind Schools board of trustees. She is very supportive of education for children who are deaf and hard of hearing. She agreed to help us finalize the draft and sponsor the bill.

On Sunday, November 29 and December 6, 2015, most of the southwestern group met to start drafting the WV DCBR using the NAD model and several DCBRs in other states.

Both groups met in Fairmont, WV, on Saturday, January 9, 2016, to complete the draft. After several revisions and e-mails, the final draft was sent to Delegate Ruth Rowan and Bill Writer John Reed on January 18, 2016.

Donna consulted with Kim Bianco-Majeri, NAD Legislative Advocate, for advice and feedback in between meetings.

In the meantime, Delegate Ruth Rowan and Bill Writer John Reed informed Donna that due to the severe WV budget deficit, the draft had to be revised to eliminate those requests that required funding, such as certified and qualified educational interpreters and teachers of the deaf and hard of hearing. The final draft of the DCBR proposed to the House of Representatives is almost identical to the DCBR in Louisiana.

The bill was finally introduced to the House of Representatives on February 10, 2016, as House Bill (HB) 4485. However, the bill was near the bottom of the list. Delegate Rowan warned both WVAD President John Burdette and Donna that the bill will most likely not go through this year for several reasons:

- 1. There were not enough sponsors. One person told Donna that this bill should have 10 to 11 sponsors, especially from the WV Legislative Education Committee. The second sponsor who agreed to work with us dropped out. He felt it was not the right time.
- 2. There were too many financial requirements in the bill. We need to reduce some of those requirements.

The WVAD Education Committee members were not very happy with the final draft; however, we all agreed to leave it as it was and make amendments

Now that legislative session is over, the WVAD Education Committee will meet again soon to make plans for the upcoming months. Both Kim Bianco-Majeri and Ann McDaniel from Fair Shake suggested we do the following:

- The Education Committee should meet with Delegate Ruth Rowan and Bill Writer John Reed to negotiate a new draft and discuss what steps we should take next.
- 2. Send the new draft to Kim Bianco-Majeri for her feedback.
- 3. Find out when legislators will meet during interim.
- 4. When the new draft is approved by all committee members, send it to various members of the WV Legislative Education Committee with a letter asking him/her to sponsor or support this bill. We have a delegate (Ruth Rowan). We need to recruit a senator. Then, together with Delegate Ruth Rowan and the recruited senator, we can recruit more sponsors.

### Why does WV need the DCBR?

- It will make sure the choice of language and communication mode of deaf/hard of hearing children is respected and to ensure these children have fully accessible educational opportunities through an Individualized Education Program (IEP) focused on language and communication needs.
- 2. It would require the IEP team to use a Language Access Plan as a critical tool to focus on the unique language and communication needs of these children. The IEP team should include an appropriate professional who is knowledgeable in the education of deaf/hard of hearing children. Specifically, the Language Access Plan would address:
  - Provide scheduled evaluations to reach fluency in American Sign Language and English; student's primary language/ communication mode chosen; opportunity for direct instruction.
  - Teach peers and role models how to communicate in the student's preferred language/ communication mode.
  - Make sure teachers and other personnel are qualified and proficient in the student's





### DIRECTIONS TO BURNSVILLE LAKE

- Make sure teachers and other personnel are accountable of providing academic instruction, school services, and extracurricular activities.
- Provide assistive devices/services; communication and physical environment accommodations that could assist in teaching language.
- Intervene if evaluations shows that language development is lacking.

- 3. It would require that parents and guardians are informed of all educational options available including WV Schools for the Deaf and the Blind (WVSDB).
- 4. It would force the West Virginia Department of Education (WVDE) to identify and keep track of students' progress towards language fluency.
- While there are several hundred deaf/hard of hearing students in West Virginia, it is considered a

low-incidence disability with just a handful of these students spread out in any one district. Many local schools have minimal experience with deafness and would benefit from a helpful tool such as the Language Access Plan to address unique language and communication needs of this low-incidence population.

### WVSDB Consolidating School for the Deaf

ROMNEY, WV—Floors are being repaired, rooms have been painted, and walls are being reconfigured to consolidate the West Virginia elementary and secondary school for the deaf.

"After holding many meetings with key school stakeholders and the administrators to discuss the feasibility ... we have determined that it would be both efficient and practical to proceed with this plan," said Martin Keller, superintendent of the West Virginia Schools for the Deaf and Blind.

Keller said in a report sent to the school community that, beginning in the fall, preschool and elementary classes for deaf students will be relocated in what is currently the secondary school for the deaf building.

The preschool and elementary classrooms will be located on the first floor and in the basement; the secondary classrooms will be primarily located on the second floor.

Due to room configurations and regulations, Career and Technical Education classrooms will remain on the first floor in a separate wing of the building, which cannot be accessed by elementary students.

Keller said specialized services such as speech therapy, occupational therapy and physical therapy, as well as the school psychology office, will be located in the basement.

"By the end of this month, we will proceed with renovating and retrofitting some of the existing classrooms in the secondary school building to better serve our preschool and elementary students' needs in preparation for the 2016-2017 school year," Keller said. "Our deaf student enrollment currently stands at 77, and the secondary school building can accommodate as many as 140 students, allowing room for future growth in student enrollment."

The work is part school's Comprehensive Education Facilities Plan, said Mark Gandolfi, the school's chief financial officer.

Keller said there are many advantages as to why the administration is proceeding with the consolidation plan, including significant financial savings in operations, staffing and maintenance, streamlined services, and creating a more inclusive learning environment.

"With the change, our younger deaf students will have more opportunities to observe and learn from older deaf student role models and it will also create opportunities to utilize studentto-student tutoring and shared reading experiences," Keller said.

During the 2016-17 school year, the elementary school for the deaf building will be used to accommodate Sign Language Proficiency Interview offices, Eastern West Virginia Community and Technical College classes and to expand the Center for Excellence in Learning and Teaching research center.

In addition, Keller said, "We are looking into the possibility of leasing some of the available classrooms to be used as office space by state government agencies as well as community business. The residential program for our elementary deaf and blind students will continue to occupy the elementary residential wing for the 2016-17 school year, which will not be accessed by the public."

A bill to make the schools eligible for state School Building Authority funding has been introduced during the current session of the West Virginia Legislature. In April 2015, Gov. Earl Ray Tomblin vetoed legislation that would give the schools that right.

Tomblin ordered a study of campus needs, which included Lynn Boyer, former WVSDB superintendent; state Superintendent of Schools Michael Martirano; Larry Malone, director of policy in the governor's office; and outside consultants.

Martirano said in the study, completed in July, that the schools were an integral component of statewide education.

In the meantime, the consolidation will continue with existing funds.


"We are truly excited about this plan and know it will pay off handsomely in the long run benefiting our deaf students' critical language, communication, cognitive, and social development," Keller said.





### **BRAISED BALSAMIC CHICKEN**

This chicken is good with either rice or pasta. Green beans or broccoli make a nice side dish.

6 skinless, boneless chicken breast halves Ground black pepper to taste 1 onion, thinly sliced 1/2 cup balsamic vinegar 1 teaspoon dried oregano 1/2 teaspoon dried thyme

1 teaspoon garlic salt 2 Tablespoons olive oil 1 (14.5 oz) can diced tomatoes 1 teaspoon dried basil 1 teaspoon dried rosemary



- 1. Season both sides of chicken breasts with garlic salt and pepper.
- Heat olive oil in a skillet over medium heat; cook seasoned chicken breasts until chicken is browned, 3 to 4 minutes per side. Add onion; cook and stir until onion is browned, 3 to 4 minutes.
- Pour diced tomatoes and balsamic vinegar over chicken; season with basil, oregano, rosemary and thyme. Simmer until chicken is no longer pink and the juices run clear, about 15 minutes. An instant-read thermometer inserted into the center should read at least 165 °F.



















### ROASTED GARLIC LEMON BROCCOLI

2 heads broccoli, separated into florets

1 teaspoon sea salt

1 clove garlic, minced

2 teaspoons extra-virgin olive oil 1/2 teaspoon ground black pepper 1/2 teaspoon lemon juice



- Preheat the oven to 400 °F.
- In a large bowl, toss broccoli florets with the extra virgin olive oil, sea salt, pepper, and garlic. Spread the broccoli out in an even layer on a baking sheet.
- Bake in the preheated oven until florets are tender enough to pierce the stems with a fork, 15 to 20 minutes. Remove and transfer to a serving platter. Squeeze lemon juice liberally over the broccoli before serving for a refreshing, tangy finish.



























### CAESAR SALAD SUPREME

6 cloves garlic, peeled 5 anchovy fillets, minced 1 teaspoon Worcestershire sauce 1 teaspoon Dijon mustard Salt to taste 1/4 cup olive oil 1 head romaine lettuce, torn into bite-size pieces

3/4 cup mayonnaise 6 Tablespoons grated Parmesan cheese, divided 1 Tablespoon lemon juice Ground black pepper to taste 4 cups day-old bread, cubed



- Mince 3 cloves of garlic, and combine in a small bowl with mayonnaise, anchovies, 2 tablespoons of the Parmesan cheese, Worcestershire sauce, mustard, and lemon juice. Season to taste with salt and black pepper. Refrigerate until ready to use.
- 2. Heat oil in a large skillet over medium heat. Cut the remaining 3 cloves of garlic into quarters and add to hot oil. Cook and stir until brown, and then remove garlic from pan. Add bread cubes to the hot oil. Cook, turning frequently, until lightly browned. Remove bread cubes from oil and season with salt and pepper.
- Place lettuce in a large bowl. Toss with dressing, remaining Parmesan cheese, and seasoned bread cubes. A wonderful, rich anchovy dressing makes this salad a meal. Serve with crusty Italian bread.
