### 2nd Annual WV Deaf Awareness Day Held at the WV State Capitol

Second Annual Deaf Awareness Day was held at the WV State Capitol, Charleston, WV, on March 13, 2017.

The event was hosted by the WV Commission for the Deaf and Hard of Hearing (WVCDHH) and WV Association of the Deaf (WVAD). A lot more people came to Deaf Awareness

Day this year and we had around 20+ vendors.

Delegate Ruth Rowan of R-Hampshire County representing the House of Delegates proclaimed and recognized WV Deaf Awareness Day. Earnest Covington III, WVCDHH Executive Director; Dr. Martin Keller, Jr., Superintendent of WV Schools for the Deaf and the Blind; and me, as President of WV Association of the Deaf, each received a Legislative Citation Award.

Afterwards, The WVSDB Tapestry and Melodies sang songs on the Upper Rotunda. They also went to the Office of the Governor and sang for the Governor in the afternoon.

- The House Bill 2571 on Language Equality Acquisition for the Deaf Kids – Kindergarten Ready (LEAD-K) for WV was introduced in the House on February 20, 2017. The bill was passed in the House on March 10, 2017. It went over to Senate and was introduced in Senate on March 11, 2017. Last action was to Senate Education Committee. They sent this bill over for a study resolution this summer. WVAD's LEAD-K team will be continuing to work on this bill. 2017 Legislative Session is over. (See story on page 14.)
- West Virginia Schools for the Deaf and Blind will be hosting Second Annual Family School Association on Saturday, May 20, 2017. # WVAD Board Meeting Held at WV Schools for the Deaf and the Blind, Romney, WV, May 15, 2016

The regular board meeting of WVAD was held at Hampton Inn in Clarksburg, WV. President John Burdette called the meeting to order at 10:08 a.m. with Secretary Donna Williams present.

- Received e-mail from Michael Squires, an audiologist in Parkersburg, WV. He wants to reinstate the camp for deaf and hard of hearing kids in WV. He is proposing a 1-week long camp during the summer at Jackson's Mill in Lewis County. He is also searching for funding to get the camp started and asked if WVAD would like to participate and/or donate. I replied to him on November 16<sup>th</sup>. Mr. Squires is interested in starting a deaf camp that was held at Jackson's Mill years ago.

- The LEAD-K bill has been introduced to the House as HB 2571.
   And, it was sent to the Education Committee. Bills never have a title so it can be confusing what each bill is about.
- Delegate Ruth Rowan did a great job getting 10 other delegates to sponsor this bill
- Donna did a PowerPoint presentation at the WVCDHH board meeting in Romney on Friday, March 3.

LEAD-K means "Language Equality and Acquisition for Deaf Kids." The goal of this law is for all babies diagnosed deaf or hard of hearing to start learning language, have their language evaluated often using milestones, monitored, and data reported from birth to age five (5) in either English, ASL, or both. The goal is for all deaf and hard of hearing children to be ready to learn when enter kindergarten. This will lead the children to be successful in school and life.

So many deaf and hard of hearing children enter school with no language and cannot communicate. The best time for children to learn language is from birth to age three (3).

There are only three states with this law: California, Kansas, and Hawaii.

The WVAD LEAD-K Team worked hard to draft a bill to propose to WV Legislators. The bill number was HB 2571. Delegate Ruth Rowan, from Romney, got 10 delegates to sponsor this bill and proposed it to the House Education Committee. The WV Department of Education requested to be removed from the bill and have only Birth to Three and WV Schools for the Deaf and the Blind responsible. I recently learned they want to work with us. It seems they completely misunderstood the bill. So, we need to work with them and clarify the bill.

The bill passed the House with no opposition and was sent to the Senate. The Senate sent it to the Senate Education Committee. The members of the Senate Education Committee had many questions. Also, there were two groups that strongly opposed the bill. Therefore, the bill failed.


It will go for a study resolution this summer. That means a group of legislators will study the bill, call some witnesses to come, and help improve the bill. In the meantime, the WV LEAD-K Team will continue to work on the bill, go to Deaf events to talk about the bill, meet with legislators, and attend a training in Richmond, VA with one of the national LEAD-K members with Virginia Association of the Deaf.

April Hottle, Antonia (Toni) Vaughan, and Brenda Hall went to the Capitol almost every day for the past 2 weeks. (April went almost everyday since legislative session started in February.) We are so blessed to have them on our Team. Twice a group from the Deaf community went to the Capitol to talk with the Senate Education Committee, but did not have a chance.

Thanks to all those who sent e-mails and called the legislators. We are NOT

giving up. We will take a short break and then meet again soon to plan for the next year.

The WV LEAD-K Team is looking for more volunteers to serve on the team. We need people who have reliable transportation to be able to attend meetings and go to the Capitol, be able to go to Deaf events to raise awareness and the purpose of the bill, meet with the legislators this summer and fall to push and discuss with them about the LEAD-K bill. 





#### CHICKEN ALFREDO ROLL-UPS

(Yield: 4 Servings; Prep Time: 15 minutes; Cook Time: 30 minutes)

3 Tablespoons butter (plus more greasing the dish) Juice of 1 lemon

2 garlic cloves, minced

2 cups shredded rotisserie chicken

8 cooked lasagna noodles

Freshly ground black pepper

3 Tablespoons flour

2-1/4 cups milk (preferably

2% or whole)

2 teaspoons chopped parsley

2 Tablespoons cream cheese, softened

1/2 cup finely grated Parmesan

Kosher salt



- Preheat oven to 350 °F. Butter a large casserole dish and set aside.
- Melt butter in a large skillet over medium heat. Add garlic and sauté until garlic is fragrant, about 30 seconds. Whisk the flour into the butter and garlic and cook until the mixture is bubbling and golden, 1 minute more. Gradually pour in milk, whisking constantly. Bring mixture to a simmer, then stir in cream cheese and Parmesan. Let simmer until the sauce thickens, about 2 to 3 minutes. Add lemon juice and about 1 teaspoon of parsley. Season to taste with salt and pepper. Then stir in shredded chicken.
- Spoon a thin layer of sauce onto the bottom of the baking dish.
- 4. Lay cooked noodles in a single layer on a cutting board or baking sheet. Spread chicken Alfredo mixture on each noodle, then roll up the lasagna noodle. Lay the roll-ups in the baking dish seam side-down. Spoon more sauce on top of the roll-ups.
- Bake for 15-20 minutes, until the sauce is bubbly and beginning to brown. Garnish with more parsley and serve warm.



#### PARMESAN LEMON CRUSTED FLOUNDER WITH GREEN BEANS AMANDINE

(Yield: 4 Servings; Prep Time: 10 minutes; Cook Time: 20 minutes)

With lean protein (flounder) and veggies (green beans), all you need to do is add brown rice to 1/4 of your plate, and this meal easily reflects the diabetes plate. See more at http://www.diabetes.org/mfa-recipes/2015-03-parmesan-lemoncrusted.html.

Cooking spray

1/2 cup panko breadcrumbs

2 tsp olive oil

1/4 cup grated parmesan cheese

1 egg white

1 lb fresh green beans, trimmed and cut in half

2 Tbsp lemon juice (use from juiced lemon above)

8 cups water

- 1 lemon, zested and juiced (juice divided)
- 2 cloves garlic, minced or grated
- 4 (4 oz) frozen flounder filets (do not thaw)
- 1 Tbsp trans-fat-free margarine
- 1 clove garlic, minced or grated
- 1/4 cup slivered almonds



- 1. Preheat oven to 375 °F. Coat a baking sheet with cooking spray and set it aside. Add 8 cups of water to a large soup pot over high heat and bring to a boil.
- In a small bowl, combine the panko, lemon zest, grated parmesan cheese, olive oil, and garlic. Mix until the panko is coated with the olive oil.
- Lay the fish filets on the prepared baking sheet and brush each filet with egg whites. Coat the top of each filet with 2 Tablespoons of panko mixture and press it in to the fish. Drizzle with 2 Tablespoons of the lemon juice. Spray the top of each fish with cooking spray.
- Bake for 20 minutes.
- While the fish is baking, par cook (blanch) the green beans in boiling water for 2 minutes. Drain and set aside.
- Add the margarine to a nonstick sauté pan over medium heat. Add the garlic, almonds, and green beans and sauté for 4 to 5 minutes.
- 7. Drizzle with remaining 2 Tablespoons lemon juice and sauté 2 more minutes.
- Build your plate with one fish filet and 1 cup of green beans.
- Serve with 1/2 cup cooked brown rice.
