NAD Leadership Training Conference '09

The 2nd annual NAD Leadership Training Conference was attended by WVAD President Linda Eckhart and Secretary Liz Leisure held on October 29 - October 31, 2009.

The theme of this year's conference was *Conquering Challenges: Leadership Beyond Barriers*.

The goal of this year's conference was to address leadership challenges and opportunities that deaf and hard of hearing individuals face within rapidly changing nonprofit, educational, governmental, and corporate environments.

Conference training areas were focused on promoting diversity and sharing of diverse viewpoints, characteristics of successful leaders, proactive

change leadership, coalition building and teamwork, accountable leaders, communicating effectively, conducting leadership search efforts, running healthy meetings, conflict resolution, and harnessing the power of social media.

Regional and affiliate caucuses were also held during the conference, to enable state association and affiliate representatives to confer on matters of importance within their respective areas. Resources support on youth leadership were also available during the conference.

WVAD Board Minutes

West Virginia Association of the Deaf Board Meeting, Comfort Suites Conference Room, Mineral Wells, West Virginia, August 6, 2009

Members Present: Doug Evans, Robyn Evans, Veronda Harrison, Liz Leisure, John Burdette, Worthy Devericks, and Linda Eckhart.

Standing Committee Members: Ruby Losh and Jimmy Harrison.

Visitors: Connie Davis, Lois Devericks, Erin Fulton, Dwight Mossor, Madelyn Mossor, Georgia Guzzi, and Jimmy Guzzi.

The regular meeting of WVAD was held in the conference room at the Comfort Suites, on Thursday morning, August 6, 2009, at 11:17 a.m. Minutes: Approved as read.

Treasurer Veronda Harrison gave the financial reports. The reports will be reviewed and audited by the trustees and two WVAD members this evening. The time will be set by the treasurer and the trustees.

President's Report:

President Douglas Evans called a special board meeting on May 30, 2009, to discuss the conference planning. All the board members attended except Liz and Linda.

President Evans announced that the new executive director for the WVCDHH has been hired and her name is Marissa Johnson. He has met with Ms. Johnson at the Fairmont Pig Roast on July 11, 2009.

President Evans has received four e-mails: The first e-mail was about the NAD Leadership Training Conference (NLTC '09) to be held at the Hyatt on Capitol Square in Columbus, Ohio, October 29-November 1, 2009. Conference registration is \$150

for NAD members and \$190 for non-members (membership is included). The hotel rate is \$82/single plus tax; \$107/double plus tax.

The second e-mail he received was from Chris Glavin who is the editor for K12 academics. Mr. Glavin wanted to post WVAD information on his website.

The third e-mail was from James Kittell who is President of ASL expo. Mr. Kittell asked WVAD if it would be interested in exhibiting its organization at their expo.

The fourth e-mail was from Jennifer Casto informing that the Sorenson Relay Services will be having an open house on August 25, 2009, from 6:30 p.m. to 8:30 p.m. in Charleston, WV.

The fifth e-mail was from Angela Holley, State Coordinator for College Goal Sunday. Ms. Holley is looking for interpreters to volunteer to interpret for students that are applying for Federal Application Financial Student Aid (FAFSA). The event will be held on February 10, 2010, from 1:00 p.m. to 5:00 p.m. at 16 different locations in West Virginia.

Vice-President's Report:

Vice-President John Burdette has attended the West Virginia Commission for Deaf and Hard of Hearing (WVCDHH) meeting on May 14, 2009. He has also met Marissa Johnson, the new Executive Director for the WVCDHH. The meeting focused on working on the Deaf Child's Bill of Rights.

Secretary Liz Leisure has no report to give at this time.

Senior Trustee Worthy Devericks said there are some money issues but will put them on hold at this time.

Trustee Robyn Evans has no report to give at this time.

Trustee Linda Eckhart reported that she has received several e-mails concerning youth conference. Many parents including deaf parents and other interested individuals have asked for information on deaf clubs and deaf events. There are new faces in West Virginia that have asked about information about deaf events.

Projects Coordinators' Reports:

There was no report on the Youth Program.

Vice-President John Burdette as Coordinator for the DDLEOS stated that Caryn Keller has designed the back of communication tips and basis signs. He is still working on the cards. He will have to rewrite the script due to person retiring. After the new script is written, he will have to get an approval. The wallet size cards are on hold.

West Virginia Video Relay Services (WVAVRS): Robyn Evans reported that there has been no "V" meeting for quite some time. The new contract with money is based on the number of the WVAD members. Each "Z150 and Z340" product that WVAD sells, we can keep half of the money.

West Virginia Telecommunications Relay Services Advisory Board - WVATRS: Ruby Losh reported that

the Public Services Commission does not want to pay mileage. Sprint Relay has won the bid to provide the relay service in West Virginia to begin on September 30, 2009.

There was no update from Mary Kesler on ASL Task Force according to Robyn Evans.

Jimmy Harrison, Membership Chairperson, announced that there were 251 WVAD members two years ago. Now there are 178 WVAD members on the roll.

Conference Chairperson Linda Eckhart reported that we have sold 63 combo tickets.

Secretary Liz Leisure reported that she has mailed out 110 letters to sponsors and received no response. She said Brianna Butler and April Hottle have agreed to be our conference interpreters.

John Burdette's Report on Workshops: Ruby Losh will give a presentation on "How to Work With an Interpreter," Donald Trembly from the Social Security Administration will talk about Social Security benefits, and John Egbert will talk about Deaf Bilingual Coalition.

Robyn Evans' Report on Exhibitors: CSDVRS cannot come to the conference but Sorenson, Sprint, HOVRS, Hamilton, SNAP VRS, and the WVCDHH will come. There will be three crafters: Eileen Brown, Connie Davis, and Lois Devericks.

Linda Eckhart's Report on Entertainment: There will be no DJ; however, Bill and Caryn Keller will lend their sound equipment. Crom Saunders from Chicago will be there to perform on Saturday night.

WVAD Booster Report: Worthy Devericks raised \$430.00 for the 2009 conference.

There was no unfinished business.

The break started at 1:35 p.m. and the meeting resumed at 1:46 p.m.

New Business:

Veronda Harrison moved that WVAD sends two delegates to NLTC in Columbus, Ohio, in Columbus, Ohio. The motion passed.

John Burdette moved that WVAD give 500 dollars (100 dollars each game) for DINGO game for prizes. Motion was passed.



Canned Deer Meat

(Submitted by Tami Kapaldo)

Cut up deer meat into small chunks. Cook in shallow pan with little bit of water on the stove (covered up with a lid) until medium done.

Pack loose in jars (that have been heated in oven) with the juice. Add 1 teaspoon of salt in each jar. Cook at 10 pounds pressure in canner. 75 minutes for pints. 90 minutes for quarts.

This is very good if you cook canned deer meat in crockpot with potatoes, carrots, celery, onions, and packet of Lipton beef-flavored soup mix.



Deer Breakfast Steaks with Gravy

(Submitted by John Burdette)

Deer steaks

Salt

4 Tbsp bacon grease or shortening

3/4 tsp pepper

Flour

Pepper

2 Tbsp flour

2-1/4 cups milk



Salt and pepper enough to coat meat with to taste. Shake the steaks in the mixture. Heat grease to sizzling and add steaks. Cook until browned. Remove steaks and set aside.

In skillet, add flour and pepper, add more shortening if needed. Stir until flour soaks up grease. Slowly add milk and stir to continue. Add steaks to skillet and bring to a slow boil over medium heat stirring constantly until gravy starts to thicken.

Cover and simmer for 10-15 minutes until steaks are tender.

Ground Deer Meat Loaf

(Submitted by John Burdette)

1-1/2 pounds ground deer

1 can (8 oz) tomato sauce

3/4 cup quick oats

1-1/2 tsp salt

1/2 tsp garlic powder (optional)

2 eggs

1 medium onion, finely chopped
(optional)

1/4 tsp pepper



In a large bowl, lightly beat eggs. Add tomato sauce, onion, quick oats, salt and pepper, and garlic powder. Add deer meat and mix well. Press into an ungreased loaf pan.

Bake, uncovered, at 350 degrees for 70 minutes.

A spokeswoman for the New York company that tentatively agreed to purchase beleaguered Rockville deaf services business Viable said this week it is now "considering its options" after Viable president John T.C. Yeh, three other Viable executives and leaders of six other companies nationwide were charged in a six-count indictment with conspiracy to defraud the federal government out of tens of millions of dollars.

Snap!VRS of Pearl River, a video relay service company, is "working through all the complications that have taken place since the indictments," said Maureen Ellenberger, vice president of marketing. Snap!VRS agreed to acquire Viable in August, but the deal has not been finalized, she said.

Snap!VRS executives released a statement saying they were "disappointed at the magnitude of unethical behavior in the use of video relay service which was revealed by the news of the FBI and Justice Department investigation. While Snap!VRS was not involved in the investigation, we are of the strong public stance that the harm done to relay consumers by the wrongful acts of some individuals is unacceptable, but these acts do not change the critical need for this technology for deaf people."

The national investigation concerns a Federal Communications Commission program designed to help deaf and hard-of-hearing people communicate with hearing persons.

Besides Viable, companies whose executives were indicted on similar charges were Master Communications of Las Vegas; KL Communications of Desert Hills, Ariz.; Mascom of Round Rock, Texas; Deaf and Hard of Hearing Interpreting Services of New York City; Innovative Communication Services for the Deaf of Miami Lakes, Fla.; and Deaf Studio 29 of Huntington Beach, Calif.

These executives fraudulently billed the FCC about \$390 an hour to interpret

calls between deaf and hearing people, federal prosecutors said. The calls, generally referred to as "r calls," "rest calls" or "run calls," were illegitimate calls often made by friends or relatives that would be billed to the FCC's video relay service fund, officials said.

Viable is the central company in the alleged scheme, directly linked via business arrangements to five of the six other companies involved. Master Communications, KL Communications, Mascom, Deaf and Hard of Hearing Interpreting Services and Innovative Communication Services for the Deaf all operated call centers for Viable that generated and processed a large volume of fraudulent calls, according to the indictments.

"These defendants are alleged to have generated fraudulent call minutes by making it appear that deaf Americans were engaging in legitimate calls with hearing persons, when in reality, the defendants were simply attempting to steal money from an FCC program that is funded by every single American who pays their telephone bills," Lanny A. Breuer, assistant attorney general of the Justice Department's Criminal Division, said in a statement released Nov. 19. The FCC program is funded through a tax on regular telephone service.

The FBI's Washington field office, U.S. Postal Inspection Service and FCC Office of Inspector General conducted the nationwide probe.

Allison Polk, a Viable spokeswoman, referred questions to Ellenberger.

Other Viable executives charged are vice president of corporate strategy Joseph Yeh, a brother of John Yeh; assistant vice president for business development Anthony Mowl; and human relations manager Donald Tropp. The charges also include submitting false claims and mail fraud.

Viable has been under a cloud since a June visit by federal investigators.

The company also has been hit with lawsuits filed in federal and state courts by employees seeking back payment of wages.

This week, Nicholas Woodfield, who is representing 114 plaintiffs in a class-action lawsuit filed in U.S. District Court in Greenbelt by former and current Viable employees seeking back wages, filed a motion for a default judgment against John Yeh, Joseph Yeh and Mary Yeh, John Yeh's wife. The filing said that Joseph Yeh had requested 20-day extensions twice to answer the complaint on behalf of the defendants, the last one being in mid-October. The Yehs had failed to respond to the complaint as of this week, according to the motion.

It's unclear what impact the indictments will have on the civil case, Woodfield said Wednesday.

"I'm sorry for my clients' sake that [Viable executives were] indicted because that is not a boon to them in their efforts to receive unpaid wages," Woodfield added. "Whether it will be significant or a bump in the road remains to be seen."

Bethesda lawyer John Pierce, who is listed as a representative for Viable in the civil class-action lawsuit, said in an e-mail this week that he was checking with his clients to see if they wanted to respond to a reporter's questions.

'Calls should look good ...important not raise red flag'

The evidence against Viable executives in the FCC case includes an e-mail allegedly sent by John Yeh in July 2007 to Larry Berke, the owner of KL Communications, which ran a call center for Viable, according to the federal indictment. Berke, of Phoenix, was also among 26 people across the country charged in the case.

"Your calls should look good — not too perfect and too long hours," Yeh wrote, according to the indictment. [\(See Fraud Charges ... page 12\)](#)

"Important not raise 'red flag' for FCC to see it. Understand me?"

John and Joseph Yeh would pay friends to generate the phony calls, officials said.

"For example, paid callers frequently called podcasts — which were prerecorded messages, like a recording of a radio program or a person reading a novel — and would routinely instruct the [video interpreters] not to actually interpret the calls," the indictment said.

John and Joseph Yeh used Mowl and Tropp to recruit relatives and friends to make illegitimate calls, officials said. Mowl and Tropp would be paid \$30 an hour of phony calls and in turn pay people \$20 to \$25 per hour to make the calls, according to the indictment.

In a little more than a year from the fall of 2007 to last January, the Yehs paid Mowl and Tropp at least \$162,000 to pay the illegitimate callers, and those fraudulent calls alone resulted in \$2.1 million to be billed to the federal government, the indictment said. The Yeh brothers would instruct Mowl, Tropp and others to destroy documents to cover up their alleged misdeeds, officials said.

The Yeh brothers would also partner with KL and other call centers, and encourage the owners of those centers to make the bogus calls, officials

said. The Yehs would instruct the owners "how to make the run calls appear legitimate" by varying the call lengths, numbers and Internet protocol addresses, the indictment said.

Snap!VRS: Critical to retain services

Because video relay services allow deaf people to have phone conversations in the comfort of their homes, rather than having to communicate via sign language in person, the technology creates economic opportunities for deaf people that were not previously possible, Snap!VRS executives said.

"Given the transformative benefits and opportunities that VRS has brought to deaf people, it is critical for Snap!VRS and other VRS companies to continue an ongoing dialogue with the FCC and consumer organizations to keep this irreplaceable service effective for relay consumers," Snap!VRS executives said in a statement. "Snap!VRS will continue to operate as it has in the past, conducting its business with the highest priority placed on ethical standards and customer service."

FCC Chief of Staff Edward Lazarus called the case both a tragedy and opportunity.

"The tragedy is the unfortunate truth that a significant number of unscrupulous individuals, at great cost to the nation, have preyed on a

very important program for delivering essential telecommunications services to persons with hearing disabilities," Lazarus said in a statement. "The opportunity is the chance to reiterate our commitment to the VRS program and to follow through on efforts, already begun at the FCC, to safeguard the program against further waste, fraud and abuse."

John Yeh has long been involved with organizations that advocate for the deaf community, such as the National Asian Deaf Congress and National Deaf Business Institute. He was a trustee of Gallaudet University of Washington, D.C., which specializes in education for deaf people, for more than a decade.

In January, Deaf Life, a monthly national magazine, honored Yeh as Deaf Person of the Year. Last year, The Gazette of Politics and Business named Yeh one of its "25 CEOs You Need to Know" and Viable as one of its "Exceptional 53" businesses and nonprofits.

A native of Taiwan who immigrated to the U.S. as a teenager, Yeh helped form a Rockville software engineering and integration company before co-founding Viable in 2005. The company grew from a handful of employees to more than 240 but has shed numerous employees and closed call centers this year. Yeh's son, Jason, and a daughter, Mei Kennedy, both work for Viable but were not indicted.

About a year ago, speaking through a deaf interpreter to a Gazette reporter, John Yeh gave little indication of any trouble.

"The company is still fairly new," he said then. "We have to be careful about what we do." (http://deafetimes.net/index.php/news/article/snapvrs_buying_viable_may_not_continue/) ■

Dr. T. Alan Hurwitz Appointed as Gallaudet University's 10th President

Dr. T. Alan Hurwitz has been appointed by the Board of Trustees as Gallaudet University's tenth president. The announcement was made by Dr. Benjamin Soukup, chair of the Board of Trustees, on October 18 before an overflow crowd in the University's Swindells Auditorium.

Hurwitz currently serves as president of the National Technical Institute for the Deaf (NTID), one of eight colleges within the Rochester Institute of Technology (RIT), and vice president and dean of RIT. He has worked at NTID/RIT since 1970, first as an instructor in RIT's College of Engineering and, subsequently, as an NTID professor, department chair, dean, and the college's president. Throughout his career he has been active in a variety of professional organizations, including serving as president of both the National Association of the Deaf and the World Organization of Jewish Deaf.

"In Dr. Alan Hurwitz the Board of Trustees has chosen a leader for Gallaudet who possesses an extensive and distinguished track record in the field of higher education for deaf and hard of hearing persons," said Soukup. "This expertise, along with his commitment to Gallaudet's unique

mission and strategic plan, ensures that he is the right person to lead the University as it seeks to attract and educate students from a variety of educational and communication backgrounds."

Dr. Soukup introduced Dr. Hurwitz and Gallaudet's new first lady, Vicki Hurwitz, to the exuberant crowd that had assembled for the announcement. Hurwitz called the occasion "a very emotional time, as well as an exciting time for me and my wife, Vicki." He thanked the Board of Trustees and the Gallaudet community "for their support and confidence in my selection," he said. "I enthusiastically accept the appointment."

Hurwitz, who will take office in January, succeeds Dr. Robert Davila, the University's president since 2007. Hurwitz said, "I'm humbled to follow in Dr. Robert Davila's footsteps," and he praised the other finalists for the position, Dr. Roslyn Rosen, Dr. Ronald Stern, and Dr. Stephen Weiner, as "outstanding individuals. ... I love all three of them." Hurwitz said he looked forward to working closely with all the University's constituents in pursuing Gallaudet's mission and strategic goals.

Davila, who joined Hurwitz on the stage, remarked, "I'm confident he'll do well," and added that Gallaudet will be fortunate to benefit from "his wealth of skill and knowledge." Noting that Hurwitz was wearing a Gallaudet jacket, Davila commented "one thing is missing," and went over to the new president to attach a "Team Gallaudet" pin to his jacket.

In closing, Gallaudet University Alumni Association (GUAA) Board President Alyce Slater Reynolds congratulated Hurwitz on behalf of GUAA's 17,000 members, and said, "We look forward to joining you on the journey we're taking." ■

Interesting Facts About WVSDB

The West Virginia Schools for the Deaf and Blind were established by an Act of the Legislature on March 3, 1870. The School for the Deaf and the School for the Blind offer comprehensive educational programs for hearing impaired and visually impaired students respectively. There is also a unit for deaf-blind and multihandicapped children. Students are eligible to enroll at the age of three. They must also be residents of the state of West Virginia and exhibit a hearing or visual loss sufficient enough to prevent normal progress in the usual public school setting. The West Virginia Schools for the Deaf and Blind are located on a campus in Romney in West Virginia's Eastern Panhandle. Locally, the schools are referred to simply as the The D&B School.

Both the School for the Deaf and the School for the Blind are supervised by the West Virginia Board of Education, supported by the state of West Virginia, and fully accredited by the North Central WVAQ Quarter News, Winter 2009

Association for Colleges and Schools at the elementary and secondary levels.

The idea to establish a school in West Virginia for the deaf and blind began in the late 1860s and early 1870s. Professor H. H. Johnson of Franklin, himself blind, was instrumental in bringing a school for the deaf and blind to West Virginia. During his youth, Johnson had attended the Virginia School for the Deaf and the Blind in Staunton, Virginia. Shortly after West Virginia's statehood, Johnson recognized the need for such a school in the state and he began canvassing the state gathering support for his project. Several towns including Romney, Clarksburg, and Parkersburg all lobbied to have the school located there, but Romney was selected following an offer consisting of the buildings and grounds of the Romney Literary Society's Romney Classical Institute. The Romney Classical Institute had laid dormant since the American Civil War when its libraries' volumes were

destroyed and its campus was left beyond repair.

On March 3, 1870, H. H. Johnson's dreams became a reality when the West Virginia Legislature approved a measure calling for the creation of the West Virginia Institution for the Deaf and Dumb and the Blind. The school opened on September 29, 1870 with thirty students, twenty-five deaf and five blind students. Through the years, additional buildings and grounds have been added to accommodate increasing enrollment. Currently, the main campus consists of sixteen major buildings, containing approximately 302,000 square feet (28,100 m²), situated on seventy-nine acres of land.

On May 17, 1916, Helen Keller visited the West Virginia Schools for the Deaf and Blind (http://en.wikipedia.org/wiki/West_Virginia_Schools_for_the_Deaf_and_Blind). ■

Mawey's Cranberry Mold Dessert (Serves 6)

(Submitted by Marilyn K. Bishop)

- 1 cup ground raw cranberries (you can use a food processor but the cranberries are a different texture)
- 1 cup ground un-pared apples (about 3); just remove the core and stem, leave the peel on
- 1 cup sugar
- 1 package lemon flavored gelatin and 3 oz raspberry for a double batch
- 1 cup hot water
- 1 cup pineapple syrup
- 1/2 cup seeded grapes halved (Mawey used one little can crushed pineapple instead of grapes)
- 1/4 cup broken English walnuts

Combine cranberries, apples, and sugar. Set aside. Dissolve gelatin in hot water; add syrup; chill until partially set. Add cranberry-apple mixture, pineapple, and nuts. Pour into mold; chill until firm. Unmold on lettuce leaves, if desired, and serve with mayonnaise.
