The Board was refreshed on communication, knowledge, creativity, time management, and organization priorities.

WVAD Board invited three knowledgeable deaf facilitators from Maryland to provide the training on various topics. We started off with Ice Breaker -The Shield which gave us an opportunity to learn more about ourselves. Then we had a refresh on the topic, diversity. We learned that the term diversity does not mean just the color of skin but our background, education, religion, and where we came from. WVAD serves different kinds of people in the State of West Virginia and we must be open minded with different perspectives. The Board then learned about different approaches and methods to recruit new



The regular board meeting of WVAD was held via Sorenson Videophone. President Chris Mick called the meeting to order at 1:05 p.m.

West Virginia Power team wore special American Sign Language-styled jerseys during the game, which were auctioned off on the Live-Source app throughout the night. They also provided interpreters at the ballpark. The proceeds of the ASL jerseys were split between four non-profit organizations that were at the ball game.

- WVAD Board members Chris Mick, Sylvia Mick, Tami Deem, and Laura Crowder attended the Hands and Voice picnic on September 28, 2019, at Sutton, WV, to represent the WVAD organization. The Board had a table set up for the event.
- WVAD had its first post-conference retreat on October 5, 2019, at Northern West Virginia Center for Independent Living (NWVCIL) in Morgantown, WV. Three knowledgeable deaf facilitators from Maryland came and hosted our retreat. This retreat started out with Ice Breaker – The Shield, Diversity Training, Membership/Volunteer Recruitment, Communication Plan, Organization Structure, Legislative Training, and Organization Priorities. This year the Board decided to have five top priorities that we will focus on for the next two years. They are (1) education, (2) branding/ marketing, (3) interpreting issues, (4) accessibility, and (5) collaboration with others.
- President Chris Mick received an e-mail from Mary Anne Clendenin (Low Incidence Coordinator/Project Director from the WV Department of Education, Office of Special Programs) on October 12, 2019, to let him know about an event that will be held by The Luke Lee Listening, Language, and Learning Lab at Marshall University. They will be hosting a 4th Annual Speakeasy Gala on November 8th, 2019. Each vear the event raises almost \$20,000 to help The "L" continue to provide services for the deaf and hard of hearing children in West Virginia and equip them to achieve listening and spoken language outcomes.
- National Leadership Training Conference (NLTC) will be held at Little Rock, Arkansas, this weekend (October 17-20, 2019). Treasurer Veronda Harrison motioned for President Chris Mick and Secretary Tami Deem to go to NLTC on October 17-20, 2019, through e-mail on August 27, 2019. Sylvia Mick seconded. ### National Leadership Training Conference at Little Rock, Arkansas

### President Chris Mick's Story

On behalf of WV Association of the Deaf (WVAD), Tami Deem and I traveled to Little Rock, Arkansas, to attend NAD's Leadership Training Conference on October 17, 2019. There were 25 workshops offered. We selected the workshops that fit our goals within WVAD. We learned a lot from the workshops that we attended.

I went to 6 different workshops: 3 workshops on Friday (October 18, 2019): (1) Grow Your Organization: Recruit and Retain Your Members, (2) Emotional Intelligence of Effective Leaders, and (3) The Many Ways to Enjoy Fundraising! First workshop - I learned about different ways to grow the organization by making it more appealing to more people so that we can draw more people to want to join and be involved; also how to keep your members in your organization. Second workshop - I learned that not all leaders are equally effective in inspiring others to collaborate as a team and the key to be a good leader depend on emotional intelligence. Third workshop – I learned about different ways to fundraise for our organization and how to make it fun, the proper way to raise money and how to properly thank your donors.

Friday evening I attended the caucus meeting. The topic was on Technology. The attendees shared ideas and input on technology and issues in this meeting.

On Saturday (October 19, 2019), I attended 3 workshops: (1) The Best Ways to Host an Organization Business Meeting, (2) The Best Ways to Run a Board Meeting, and (3) Managing Your Organization's Money. First workshop -I learned how to run the conference business meetings the right way and to make it flow smoothly from start to end. Second workshop - This workshop showed me the best way to run a board meeting, focusing on steps that are useful in structuring meetings ahead of time and how to open the meeting, discuss each issue in a constructive way, complete all necessary items, and bring the meeting to a close with everyone satisfied. Third workshop this workshop showed me how to handle the organization's money the right way and the best ways to handle money that comes in and goes out.

After the workshops, I attended NAD's Region 1 meeting to talk about problems the deaf and hard of hearing community face. We also selected the most issues that need to be worked on by NAD so that we can bring it to the table at NAD's Biennial Conference in Chicago on July 2020. NAD will then decide which issues will be selected as their priorities to work on for years 2020-2022.

On Saturday evening, Arkansas Association of the Deaf hosted "Deaf Night Out" at Fassler Hall (a German Inspired Beer Hall and Pub) to enjoy the last night of the conference.

I want to thank WVAD for sponsoring Tami Deem and I to go to this important conference.

#### Secretary Tami Deem's Story

WVAD sent President Chris Mick and I to Little Rock, Arkansas, on October 17, 2019, to attend NAD's (National Association of the Deaf) Leadership Training Conference (NLTC). There were 25 workshops offered. We selected the workshops that fit our goals within WVAD. We learned a lot from the workshops that we attended.

I attended 3 different workshops on Friday (October 18, 2019): (1) Legislative and Advocacy Updates, (2) Create Awesome and Accessible Videos, and (3) The Many Ways to Enjoy Fundraising!

The first workshop was very interesting. NAD shared which state laws have been passed such as LEAD-K, Deaf Child Bill of Rights, deaf mental health rights, interpreter licensure, open captioned movie theater requirements, deaf and hard of hearing commission creation, and changing the terminology in all state laws to "deaf and hard of hearing." NAD is working with states on how to write a good bill for interpreter licensure. They also have several model bills on their website that we can use for our states.

NAD shared their upcoming projects which include interactive website, family resources/ASL resources, and more targeted trainings for State Associations/affiliates and education advocates. NAD is working on a big project on their website. They are collecting what info is available for each state. The map will have a drop down box for the state you would click on and it would show what resources are available in that state. They are also making a list of places where parents or families can find out where ASL classes are available within each state.

NAD is working on offering training webinars. It is cheaper for them to do webinars than to travel and give training. They also developed education curriculum videos on YouTube. NAD wants to do a webinar on collaboration as well (how to collaborate with other agencies).

They shared with us information about DNA genetics testing that would cure deafness and hearing loss which could occur within the next 5 years. World Health Organization (WHO) found out that there's information on the internet on how to modify DNA genetics and told them to stop because they need to discuss and look into bioethics. NAD has a bioethics expert that keeps up to date on what's going on with this new technology and gets updated info on bioethics. NAD said that they need to make a vlog on bioethics to explain it better in depth. They want you to let them know if you know of any deaf scientists that have a degree in biometrics, biology, etc., to get them in touch with NAD so they can develop a relationship with them and have them keep NAD aware of what's going on with biometrics.

The second workshop showed us how to make your vlogs/videos accessible and how to caption them. One tip they shared was to make the vlog in YouTube and save it to a file. Also save your caption file (SRT file). Then upload that video to Facebook or any social media platform. Do not copy and paste from YouTube to a social media platform because the quality would not be as good. You can force captions (See National Leadership... on page 6)

to be on in YouTube settings. Facebook does not have that force captions option. Make your videos simple and get the content across. Also use hashtags for search engines to find your videos easier. Do videos in horizontal view (landscape) not portrait. Make sure videos are muted so that background noise does not pick up in your videos. If you want information on how to do this, please contact me or Laura Crowder (our WVAD trustee). We will be happy to help you and send you the PDF file from NAD on this workshop.

The third workshop was about fundraising. The objective of fundraising is to raise money for your organization and network with people, not to raise awareness about your organization. Different types of fundraising can be annual events, auctions, restaurants, products, raffles/drawings, run/walk, and appeal letters. Be creative when fundraising! We can also do fundraisers at tea parties, costume contests, silent auction at an event, social media campaign, and local restaurant/bar. Invite "VIP" to "work" at your event and make them feel valued. Engage when you are fundraising by listening, sharing, and communicating with people and donors. Show appreciation while fundraising. Always thank your donors! Thank them at least 7 TIMES! Celebrate success!

Friday evening I attended one of the caucus meetings. The topic was on Education. The attendees shared ideas, concerns, and issues the states are facing regarding education for deaf and hard of hearing children. Some of them shared their life experience and frustrations they face in trying to get a teaching job because of the Praxis exams that teachers have to pass first before getting a teaching job. A lot of deaf teachers who are certified to teach cannot pass the Praxis tests. We want NAD to work on a special Praxis test designed for deaf teachers only. This explains why there's a shortage on deaf teachers for deaf and hard of hearing children.

On Saturday (October 19, 2019), I attended 3 workshops: (1) Developing and Retaining Passionate Boards/Committees, (2) Encouraging Youth for Success!, and (3) Instilling Advocacy Skills in Deaf Youth. Developing and Retaining Passionate Boards/Committees workshop was very interesting and engaging as well. Every organization struggles with finding and retaining dedicated and strong individuals to serve as Board members as well as on committees. Many people today are busy with work, family, and other priorities so it is difficult to recruit the right people who have the expertise, necessary skills, the available time, and the committed drive to serve on our organizations.

We all have the same common goals and concerns: have a strong sense of community and leadership, concerned about shrinking organizations, changing landscape of state associations, board/committee aversion/turnover, looking for ways to develop/retain talent, acquire new self-learning skills/ knowledge, and grow winning boards/ committees.

Passion starts with you! Passion creates energy, vision, ignition, influence, and potential. We learned that passionate leaders take the time to communicate with others, provides clear and concise expectations in a supportive (and fun) environment, strongly believes in the organization itself, takes the time to learn about people's interests and what inspires them, recognizes and thanks board/committee members for their contributions. Passionate leadership is what you make of it in your own style by inspiring and motivating your board and committees to do their very best for others.

The second workshop was about Encouraging Youth for Success! Everyone knows that young people are our future but are we doing enough to ensure a strong future? Sometimes it is difficult for different generations to communicate so NAD shared the best way to bridge this generational gap. NAD suggested that we invite Jr. NAD chapter to our organization meetings, establish metro Jr. NAD chapters, have Jr. NAD pages (volunteers) at our conferences, connect with Jr. NAD advisors and ask them if we can come to their meetings, collaborate events and fundraisers, connect with the selected Jr. NAD delegate in our state. They recommend that we encourage our members' deaf children to apply for Youth Leadership Camp (YLC); invest in our youth by financing their YLC tuition; invite YLC alumni to our conferences, meetings, and events; ask YLC alumni to give a workshop, presentation, or take part on a panel; ask them to lead a Youth Day for our organization. They also recommend that we host Youth Ambassador Program (YAP) within our organization with a private interview and pitch competition. Contact local high schools and universities and invite deaf/hard of hearing students to participate in the YAP. For more information on YLC and YAP, please visit the NAD website: www.nad.org. We must invest in deaf youth and our future!

The third workshop: Instilling Advocacy Skills in Deaf Youth. Advocacy is not inherited, it must be taught. We, as deaf people, are all too familiar with having to advocate for our own basic civil rights including communication access. What about deaf youth? Many are mainstreamed and may not receive information or training necessary to self-advocate when they go to college or university, or when they seek jobs, or simply getting access at their doctor's office or at conferences or events. Even deaf students from deaf schools may not get the self-advocacy training they need, given that most deaf schools are more accessible than the world at large. Our organization can be the key to making sure deaf youth gain the skills and knowledge they need to be effective advocates for their own civil rights.

Common barriers are lack of role models, few or no peers with healthy identities, quality of language access, appeasing access gatekeepers, dominant cultural views. Encourage connection with deaf peers (afterschool and summer programs, summer camps like YLC, and others), social events, deaf club events for deaf youth, support local organizations in hosting events open to all deaf youth.

Instilling Advocacy: Role Models. Expose to role models in schools such as push for deaf staff hires, encourage deaf staff to sponsor activity and advertise to deaf students, create 1:1 opportunities for deaf staff with students. Encourage deaf community involvement.

Instilling Advocacy: Support Networks. Encourage discussing advocacy (See National Leadership... on page 7) WVAD Quarter News, Winter 2020 (National Leadership... from page 6) challenges with their peers and deaf adults such as community events, social media, online forums, Jr. NAD chapter. Listen to and validate their concerns. Provide tools to describe challenges in a clear and constructive way.

There are resources on advocacy (national organizations, state-level organizations, local organizations, local events such as fairs/expos, deafrun media outlets). Don't assume families have received even basic info!

After the workshops, we attended NAD's Region 1 meeting to talk about problems the deaf and hard of hearing community face. The topics were Access, Education, Employment, Mental Health and Health, and Technology. We also selected the most issues from those five categories that need to be worked on by NAD so that we can bring it to the table at NAD's Biennial Conference in Chicago July 2020. NAD will then decide which issues will be selected as their priorities to work on for years 2020-2022.

On Saturday evening, Arkansas Association of the Deaf hosted "Deaf Night Out" at Fassler Hall (a German Inspired Beer Hall and Pub) to give us the opportunity to network and socialize with others the last night of the conference. I want to thank WVAD for sending Chris and I to the NLTC conference to bring back information, tools, and knowledge that we learned at the conference for our organization and the deaf community.



The rest was history. They celebrated 60 years of marriage prior to his death in 2014.

Hampshire County Schools after graduating from Romney High in 1950 and taking continuing education classes. After 30 years, she finished this stage of her career at the Hampshire County Career Training Center and moved on to work as an aide and bus driver for the West Virginia Schools for the Deaf and Blind (WVSDB). She spent 25 more years working part-time at WVSDB. Over the years, Betty often remarked that she had the most wonderful bosses and co-workers.

Betty was a three-time cancer survivor who served as an inspiration to other survivors. She was a member of the American Legion Auxiliary (ALA), Kirby Post 134, as her husband was a Navy veteran of the Korean War. She spent countless hours cheering on the West Virginia University (WVU) Mountaineers, working with her plants and flowers, reading, riding around the farm, thrifting, shopping, and interacting with her friends on Facebook. As those who knew her will certainly remember, Betty never shied away from expressing her opinions; even in her final days she was still affectionately called the Loy's Farm Administrator. Her valued insight will be sorely missed in life and business. As a final act of generosity, Betty donated her body to the WVU Human Gift Registry.

Betty is preceded in death by her husband, Gary R. Loy. She is survived by her daughter, Dr. Beth Loy with fiancé Samantha Hott, of Morgantown and her constant companion Madison. communication relations, planning, and leadership skills.

At the retreat the Board chose five top priorities that we will focus on and are committed to work on them for the next two years. Education - we will be working on the LEAD-K bill, branding and marketing to spread awareness about our organization, interpreting issues that the deaf community faces in the State of West Virginia, and collaboration with others so that we can work with the state government and other organizations to improve the lives of the deaf citizens in the state.



### SPINACH LASAGNA ROLLS

### (https://www.skinnytaste.com/spinach-lasagna-rolls/)

(Prep Time: 20 mins; Cook Time: 40 mins; Total Time: 1 hour; Yield: 9 rolls)

These easy spinach lasagna roll ups are totally delicious, perfect for entertaining or serving for week night meals. Freezer friendly.

2 cups homemade marinara sauce (see below for recipe) plus more for serving
10 oz package frozen chopped spinach, thawed and squeezed well
15 oz part skim ricotta cheese
9 Tablespoons (about 3 oz) part skim mozzarella cheese, shredded

- 9 uncooked lasagna noodles, wheat or gluten free
  1/2 cup grated Parmesan cheese
  1 large egg
  Kosher salt and fresh pepper
- 1. Preheat oven to 350 °F. Ladle about 1 cup sauce on the bottom of a 9x12 baking dish.
- 2. Cook noodles according to package directions, then drain.
- 3. Combine spinach, ricotta, Parmesan cheese, egg, 1/2 teaspoon salt and black pepper in a medium bowl and mix.
- 4. Place a piece of wax paper on the counter and lay out lasagna noodles. Make sure noodles are dry. Take 1/3 cup of ricotta mixture and spread evenly over noodle. Roll carefully and place seam side down onto the baking dish. Repeat with remaining noodles.
- 5. Ladle remaining sauce over the noodles and top each one with 1 Tablespoon mozzarella cheese. Put foil over baking dish and bake for 40 minutes, or until cheese melts.
- 6. To serve, ladle a little sauce on the plate and top with lasagna roll.

### Homemade Marinara Sauce

This would also be great for baked pasta recipes, eggplant parmesan, french bread pizzas, or dipping sauce for zucchini sticks, mozzarella sticks, or anything you like to serve with sauce.

1 teaspoon olive oil 28 oz can crushed tomatoes 1 teaspoon oregano Salt and fresh pepper to taste 2 cloves garlic, smashed 1 small bay leaf 2 Tablespoons chopped fresh basil

- 1. In a medium pot, heat olive oil over medium heat.
- 2. Add garlic and saute until golden, being careful not to burn.
- 3. Add crushed tomatoes, salt, pepper, oregano, and bay leaf. Stir and reduce heat to low.
- 4. Cover and let simmer for about 15 to 20 minutes.
- 5. Remove from heat and add fresh basil.

1 can apple pie filling, mashed
1 box of yellow cake mix
4 eggs, slightly beaten

1 cup self rising flour 1 Tbsp cinnamon 1 medium chopped apple

- 1. Preheat oven to 325 °F. Spray 2 loaf pans with cooking spray or you can use cupcake liners.
- 2. Whisk all dry ingredients together. Add wet ingredients and fold in apples.
- 3. Pour in 2 greased loaf pans or cupcake pan. Sprinkle sugar and cinnamon on top.
- 4. Bake for 35 to 45 minutes. Cool and enjoy!
